## Food Grade Statement

(PPS446, Rev. 1.0, 12/19, CWB)

Glycerin products sold by Greenfield Global USA Inc. are suitable for materials and articles intended to come into contact with food and use in food and beverage applications as specified in following regulations:

  - Commission Regulation (EU) 10/2011 Glycerol is listed in the latest version of Commission Regulation (EU) 10/2011 on plastic materials and articles intended to come in contact with food. Glycerol (FCM Substance No 103) is listed in ANNEX I, Union list of authorized monomers, other starting substances, macromolecules obtained from microbial fermentation, additives and polymer production aids. Use as additive or poly production aid (Table 1). There are no restrictions and/or specifications indicated.
  - Resolution AP (2004)1 –Glycerol is included in A. LIST 1 OF MONOMERS of resolution AP (2004) 1 on coatings intended to come in contact with foodstuffs. There are no restrictions and/or specifications indicated.
  - Swiss Ordinance 817.023.21 Glycerol is listed in Annex 6, List of Solvents, List of Binders, and List of Additives, Part A: Evaluated Substances. There are no restrictions and/or specifications indicated.
