- Never give anything by mouth if victim is rapidly losing consciousness or is unconscious or convulsing.

Mild alcohol intoxication occurs at blood levels between 0.05% 0.15% and approximately 25% of individuals will show signs of intoxication at these levels. Above 0.15% the person is definitely under the influence of ethanol and 50-95% of individuals at this level are clinically intoxicated. Severe poisoning occurs when the blood ethanol level is 0.3-0.5%. Above 0.05% the individual will be comatose and death can occur.
- The unabsorbed ethanol should be removed by gastric lavage after intubating the patient to prevent aspiration.
- Avoid the use of depressant drugs or the excessive administration of fluids.
- This product also contains acetone at a concentration of 7.4% volume.
